APPROPRIATION ORDINANCE NO. 020-2024

“AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 06 FOR CALENDAR YEAR 2024 OF THE PROVINCE OF ZAMBOANGA DEL SUR WITH THE TOTAL AMOUNT OF THIRTEEN MILLION PESOS ONLY (PHP13,000,000.00).

WHEREAS, Hon. Victor J. Yu, Provincial Governor of the Province of Zamboanga del Sur, in line with the priority agenda of the present administration and in consonance with the provision of Republic Act No. 7160, otherwise known as “The Local Government Code of 1991”, submitted to this August Body the Province’s Supplemental Budget No. 06 for Calendar Year 2024 with the total appropriation of Php13,000,000.00 for urgent consideration;

WHEREAS, the province’s supplemental budget, after having been thoroughly perused and having taken into consideration SP Resolution No. 2205-2024 that approved the programs, projects and activities identified under Supplemental Budget No. 06, CY 2024 with prior adoption by the PDC through PDC Executive Committee Resolution No. 23, Series 2024, is found to be sound and necessary within the framework of budgetary guidelines;

NOW, THEREFORE, be it ordained, as it is hereby ordained by the Sangguniang Panlalawigan of the Province of Zamboanga del Sur, in session assembled, to enact an ordinance as cited hereunder:

SECTION 1 – TITLE. The Ordinance shall be entitled as “An Ordinance Authorizing the Supplemental Budget No. 06 for Calendar Year 2024 of the Province of Zamboanga del Sur with the Total Amount of Thirteen Million Pesos Only (Php13,000,000.00).”

SECTION 2 – SOURCES OF FUNDS. The sources of funds amounted to Thirteen Million Pesos Only (Php13,000,000.00), broken down as follows:
