## **APPROPRIATION ORDINANCE NO. 027-2025**

"AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 3 IN THE AMOUNT OF TWENTY-EIGHT MILLION SIX HUNDRED EIGHTY-SIX THOUSAND PESOS (PHP28,686,000.00) OF THE PROVINCE OF ZAMBOANGA DEL SUR FOR CALENDAR YEAR 2025."

WHEREAS, in line with the priority agenda of this administration and in consonance with the provision of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991," Hon. Victor J. Yu, Provincial Governor of the Province of Zamboanga del Sur submitted to the Honorable Members of the Sangguniang Panlalawigan the Supplemental Budget No. 3 for CY 2025 with the total appropriation of Php28,686,000.00 for appropriate action;

WHEREAS, after the matter was referred to the Committee on Appropriations/Finance, Ways and Means for further study and subsequently reported to the plenary for acceptance by this Body, the Supplemental Budget No. 3 for CY 2025 of the Provincial Government of Zamboanga del Sur was recommended for its approval with the following remarks:

- "1) That the availability of funds for the supplemental budget was certified by the Acting Treasurer, Accountant, Budget Officer, OIC-Planning and Development Office and the Provincial Governor, all of this province;
- 2) That this appropriation ordinance is pursuant to the Provision of Section 322 of the same Code which states:
  - "Reversion of Unexpended Balances of Appropriations, Continuing Appropriations Unexpended balances of appropriations authorized in the annual appropriations shall revert to the Unappropriated Surplus of the general fund at the end of the fiscal year and shall not thereafter be available for expenditure except by a subsequent enactment (ordinance)."

**NOW THEREFORE**, be it ordained by the Sangguniang Panlalawigan of Zamboanga del Sur, in session assembled that:

SECTION 1. TITLE - This Ordinance shall be titled as "AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 3 IN THE AMOUNT OF TWENTY-EIGHT MILLION SIX HUNDRED EIGHTY-SIX THOUSAND PESOS (PHP28,686,000.00) OF THE PROVINCE OF ZAMBOANGA DEL SUR FOR CALENDAR YEAR 2025."

SECTION 2. BASIS – The Supplemental Budget No. 3 for CY 2025 of the Province of Zamboanga del Sur with the total appropriation of Php28,686,000.00 was prepared in accordance with Section 318 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines.
